

Sometimes, what you see isn't what you get. If you're considering purchasing new Association Management Software (AMS) be sure that when you're looking at pricing, you're including possible hidden fees and additional charges that can turn what seems to be a bargain, into an expensive mistake. Use the worksheet below to calculate and compare the true total cost of ownership of your next AMS. ### **SECTION 1: ANNUAL FEES**

To start, enter the fees that you'll be required to pay each year of the contract. These include fees for upgrades, dedicated support, reporting, a website and module-related fees. Total these fees and multiply by the number of the years of the contract.

#### **SECTION 2: ONE-TIME FEES**

Now that you have gathered annual fees, it is time to enter and calculate the one-time fees. These are typically related to reporting and implementation of the system.

## **SECTION 3: TOTAL FEES**

Finally, add the total fees calculated in section 1 to the one-time fees calculated in section 2. The sum of these fees represents your total cost of ownership over the lifetime of the contract.
